



TERMS AND CONDITIONS

ORDER

- 1 Each order form should contain one delivery address only.
- 2 Stockists are not eligible to participate in this program.
- 3 Autoship program is not run in conjunction with any other promotions, and is not exchangeable for products of the same value. Volume is non-transferable.

DELIVERY OF ORDERS

- 1 Any delivery time published by the Company or quoted by the Company's Customer Service is only an estimate and is not the delivery commitment time.
- 2 Applicant must inform the Company of any changes to the delivery address in writing.
- 3 Deliveries are made upon clearance of payment. Day of delivery may be subject to changes.
- 4 Deliveries are made upon receipt of Post-Dated Cheques for 12 months (payable to Viva Life Science Pte Ltd)
- 5 If in any month, cheque is dishonored by bank, delivery will ceased and free item will be forfeited.
- 6 Deliveries cannot be made to PO Box addresses. Deliveries are made to home and office addresses on mainland Singapore only.
- 7 Products will be delivered once only. If products are not received during first delivery, charges for 2nd trip will be borne by distributor.
- 8 Order for the first month may be collected at the time of submitting this form, once the payment is made, otherwise the products will be delivered on the next delivery day.
- 9 Order for the 2nd and subsequent months will be delivered on the 18th of each month. All deliveries will be arranged by the Company.

- 2 The Company is not liable for any damages or loss caused by delays or failure to deliver due to circumstances beyond the Company's control, including improper or incomplete delivery instructions or information, or unavailability or refusal of Receiver to accept delivery.

TERMINATION
